

- 6. Brenda Coles 6710 N. Noffke Dr. She asked about chip sealing and was concerned about the amount of gravel that comes down the hill and ends up at the end of her driveway.
- 7. Emily Haaksma 6580 N. Noffke Dr. She asked how the special assessment would impact the sale of a home.
- 8. Kay Genther 7487 N. Noffke Dr. Genther asked if the homeowner association would have any liability if there was a special assessment and something happened on the road. Welch answered no.
- 9. Bob Koster 6323 N. Noffke Dr. Koster said he would like to see the petitions and had questions about how the signatures were counted.
- 10. Jacob Welch Barry County Road Commission Welch explained that special assessments do occur on public roads and that it is preferable to some of the alternative ways of paying for road improvements.
