- **9. EMERGENCY SERVICES REPORT:** Chief Richardson said there were 241 response calls in January, which may be the busiest month ever for the department. There were four structure fires. Two were mutual aide structure fires and two structure fires were in the community. There were also ten vehicle accidents and seven wire down incidents, during the winter storm.
- **10. PLANNING AND ZONING REPORT:** Gensterblum said it has been slower this month with just one permit for an accessory building. There were a couple of code enforcement issues that turned out not to be anything.

12. NEW BUSINESS:

A. Resolution 01-2024 – Selleck stated that he supports all the Constitutional Amendments and the Bill of Rights. He doesn't like the idea of separating out just one. Also, tomorrow is the one-year anniversary of the MSU school shooting and over the weekend there was a shooting at a large church in Texas. Sixty percent of Americans say gun violence is out of control. He feels he can't support just one amendment above all the rest. Ordway stated that when she became Clerk for the Thornapple Township, she took her Oath of Office stating that she would support the Constitution of the United States and the

Constitution of the State of Michigan, and that she would faithfully discharge the duties of the Office of Thornapple Township Clerk. When she took the oath, she meant it and the Constitution includes the Second Amendment. She made a promise to support it and will do so. Campbell asked Schaefer if the resolution had been reviewed and approved by the township attorney. Schaefer said he had. DeMaagd said he strongly supports the second amendment and supports all the Amendments. He had asked that the resolution read, "Be it further resolved that Thornapple Township Board will defend the Constitutional Rights of the citizens of Thornapple Township from all infringements." But this resolution ends with the statement is that "I support the entire Constitution," which is not the same. The Second Amendment language is strictly symbolic, but he does like to make the statement. Campbell said he supports what Selleck, Ordway and DeMaagd said. Bouchard said that all board members took an oath of office stating that they support the whole Constitution, and this resolution just repeats that.

C. Ambulance Replacement Plan – Chief Richardson said the new ambulance order had been withdrawn last month and this is a follow up to that discussion. He felt he could buy a new ambulance and have one refurbished for about the same price as the order that was canceled. There are two older ambulances that have taken a lot of maintenance the last six months. There was one that was out of service for about eight weeks. He would like to keep three units in service. This plan allows them to have a new

ambulance so that if one is out of service, they could still have three units in service at any given time. DeMaagd asked if the original ambulance they were looking at was still available. Chief Richardson said that it was. Rairigh asked if the additional costs of the power cot, AED and other items were included in the price. Chief Richardson confirmed they were.

Schaefer explained they are over 20 years old and the other units that were that old had already failed and been replaced. Rairigh asked about the date of the quote and Schaefer stated that he would call them to confirm but thinks they will be ok with it.

F. Flagpole for Mt. Hope Cemetery – Schaefer explained the Veteran's Committee is going to have an upgrade to their flagpole, and they would like to give their old, but in good condition flagpole, to the township for Mt. Hope Cemetery. It is 25 feet tall, seven years old and valued at \$3,500. The cost to have it installed would be \$850. It would need to be illuminated at night, so there would be a need for some kind of solar lighting as the cemetery doesn't have electricity. Schaefer said that he would be looking into the specifics but is expecting to complete it at a cost NTE \$1,500. Rairigh asked if three quotes were required first. Schaefer said Flags Unlimited would be installing the flagpole at the Veteran's Memorial already, so the quote he got was likely less than if they came out just for the Mt. Hope installation. Schaefer feels that if he could get approval for a cost NTE \$1,500 he could then get other quotes to come up with the three quotes needed.
